3. PROPOSAL

To implement various parking / waiting restrictions around the North East Somerset area.

4. BACKGROUND

A number of proposals for: No Parking At Any Time markings, Reduction of existing No Parking At Any Time markings, Disabled Parking, Restricted Parking Zone and No Parking / No Loading At Any Time at various locations around the North East Somerset area were submitted to the Council by local residents, Ward Members and the Bath & North East Somerset Councils Traffic Management and Transport Planning Engineers. The reason behind these requests was to improve visibility and access for emergency and refuse vehicles, to allow for the safe passage and repassage of vehicles and to provide limited on-street parking provision. These proposals have all been considered by the area Senior Safety Engineer.

5. SOURCE OF FINANCE

This proposal is being funded by the capital Parking budget, project code TC8302.

The proposal requires informal consultation with the Chief Constable, Ward Members and the Cabinet Members for Transport.




Plan 32 - Trollopes Hill, Monkton Combe - No Parking At Any Time restrictions were



The Bay is essential for a resident in these cottages. We trust and hope that this will proceed through the Public Consultation without any problems and is then implemented early next year, in advance of the summer period when it is very likely to be needed again.



Paulton:

Cllr Liz Hardman / Cllr Grant Johnson – Plan 15: Ham Lane/ Brookside: We would like to express our support for the inclusion of double yellow lines around the corners of Brookside/ Ham Lane. This has been requested by our residents to avoid traffic congestion and hold ups along Ham Lane. This is particularly needed when there can be additional road parking opposite the Central Garage. We also endorse the inclusion of double yellow lines opposite houses such as "The Bramleys" and Jasmine. The road begins to narrow at this point, making it difficult for residents to exit their properties if cars are parked opposite. I have viewed for myself the difficulties facing residents trying to leave their homes.

Plan 12: Farrington Road/Abbotts Farm Close: We would like to express support for the inclusion of double yellow lines on the corner of Abbotts Farm Close. This will help visibility at a dangerous junction, where the Downsway Road meets Farrington Road. However, we do feel strongly that the double yellow lines should be extended further south along Farrington Road. Cars are parking on the brow of a hill, immediately south of these proposed double yellow lines. The visibility is extremely poor because the parked cars block visibility for vehicles coming from Farrington. We have been so lucky there hasn't been a major accident yet. I would suggest 20 paces to the south, midway between the bus stop and the 20mph sign, for the proposed extension of the double yellow lines.



Paulton Parish Council – Many thanks for the information concerning the proposed Traffic Regulation Orders for Paulton. Plan 15: Ham Lane/ Brookside: On behalf of Paulton Parish Council, I would like to express our support for the plan for double yellow lines around the corners of Brookside/ Ham Lane. This has been requested by our residents to avoid traffic congestion and hold ups along Ham Lane, especially where there can be additional road parking opposite the Central Garage. We also endorse the inclusion of double yellow lines opposite houses such as "The Bramleys" and Jasmine, where I have viewed for myself, the difficulties facing residents in trying to egress their properties, when cars have been parked opposite. The road starts to narrow at this point, making it difficult for residents to drive out of their driveways.

Plan 12: Farrington Road/Abbotts Farm Close: On behalf of Paulton Parish Council I would like to express support for the inclusion of double yellow lines on the corner of Abbotts Farm Close, which will help visibility at a dangerous junction, where the Downsway Road meets Farrington Road. However, we do feel strongly that the double yellow lines should be extended further south along the Farrington Road. Cars park immediately south of these proposed double yellow lines and are at the brow of a hill. The visibility is extremely poor as the parked cars block visibility for vehicles coming from Farrington. We have been so lucky there hasn't been a major accident yet. I would suggest 20 paces to the south, midway between the bus stop and the 20mph sign, for the proposed extension of the double yellow lines.

I do hope you can consider the amendment suggested.

Response: Please see above the amended proposal plan for Farrington Road / Abbotts Farm Close as requested by the local Councillors Liz Hardman and Grant Johnson and the Paulton Parish Council.

Peasedown St John:

Cllr Sarah Bevan – I support all the proposals.

Cllr Karen Walker – Happy to support both recommendations.

Peasedown St John Parish Council – Plan 2 "No parking at any time" around the width restriction: this may be required to improve visibility for cars pulling out around the width restriction, but it would remove the only available parking outside 5 and 6 Ashgrove, in an area where there is already insufficient parking for local residents. A better solution might be to remove the width restriction entirely, and to reinstate the parking spaces that it has replaced. The current arrangement with the width restriction and speed table is extremely dangerous for pedestrians, because the pavement opposite the width restriction is very narrow and following resurfacing of the whole road some years ago, the speed hump is now at the same level as the pavement and at a very similar level to the rest of the road (so no longer slows the traffic down). On the contrary, cars often speed up to get through the width restriction quickly, so that they don't have to give way to traffic coming the other way.

Plan 2 & Plan 3

The proposals for Ashgrove are likely going to make parking worse for the residents there. That will be an additional 3-4 cars that will have to find on-street parking because of the two proposals on Ashgrove. They already fill every inch they can, particularly at the width restriction which I imagine makes it a nightmare for buses.

Plan 11

The residents can't get out of the drive if someone parks opposite on the tiny space. although hardly anyone parks there (we park on the drive) so not sure of the point of double yellows we all get on well as a close and park respectfully

Plan 19

It is thought this one may be due to a resident not liking people parking near their house and not due to safety concerns. Other residents have been spoken to in the area and believe it is not necessary as there is no parking issues at this location. This section of road on Church Lane is single carriageway anyway and so not possible to park on without blocking the entire road.

They all seem to be nimbyism at their neighbours expense. Basically, moving a problem from one place to someone else's. There needs to be a holistic approach not slapping yellow paint down to please individuals. They all appear to be non-essential.


